**Invitation of Tender for Grant of License
to Operate A Retail Shop
at the Hong Kong Jockey Club International BMX Park**

The Cycling Association of Hong Kong, China Limited (the "CAHK") invites tender for operating a Retail Shop located inside the Function Room 1 at the Hong Kong Jockey Club International BMX Park. Details and conditions are stated as below:

- Premises:** A shop located inside the Function Room 1, the Hong Kong Jockey Club International BMX Park, 91 Kwai Hei Street, Gin Drinkers Bay, Kwai Chung, New Territories
- Size:** 11 feet x 15 feet (approx. 165 sq.ft.)
- Opening Hours:** Limited to the opening hours of the Park (including any deliveries)
- Term:** Two years (Expected commencement date 1 June 2018)
- A security deposit equivalent to Two months fee is required.
 - License fee is payable by the Contractor monthly in advance.
 - The CAHK reserves the right to early terminate the contract by issuing 2 months' notice in advance.
- Restrictions:**
1. Bonfires or flames is strictly prohibited.
 2. No alcoholic beverage.
 3. The shop must be kept clean and tidy at all times.

Please submit all relevant information in the Proposal including but not limited to the followings:

5. Products to be displayed and/or sold in the shop
6. Shop name intended to use (subject to CAHK's approval)
7. Opening Hours
8. Proposed monthly fee for Year 1 & Year 2
9. Contact Details

The acceptance of a Tender will be at the sole discretion of the CAHK. The CAHK shall not be bound to accept the highest, the best or any Tender or to enter into any agreement with any Tenderer.

Notwithstanding that a term of this Tender Invitation purports to confer a benefit on any person who is not a party to this Tender Invitation, a person who is not a party to this Tender Invitation shall have no rights under the Contracts (Rights of Third Parties) Ordinance (Cap. 623) to enforce or enjoy the benefit of any provision of this Tender Invitation.

The tenderer shall not and shall ensure that his agents and employees do not give or offer any advantages as defined under the Prevention of Bribery Ordinance to any agent or employee of the CAHK. The tenderer is also prohibited from colluding with other bidders in this tendering exercise in whatever forms (e.g. price rigging). Any breach of or non-compliance with these clauses by the tenderer shall, without affecting the tenderer's liability for such breach or non-compliance, invalidate his tender.

If the contractor or any employee or agent of the contractor shall be found to have committed an offence under the Prevention of Bribery Ordinance in relation to the tender or the contract, the CAHK may terminate the contract without entitling the contractor to any compensation therefore, and the contractor shall be liable for all losses and expenses necessarily incurred by the CAHK as the result of such termination of the contract.
